CONDITIONS OF SALE

1. All sheep to be moved with a pre-movement licence AML1 – obtained from your Local Authority (Trading Standards).
2. All sheep must be tagged in accordance with the Sheep and Goats (Records, Identification and Movement) Order 2010.
3. None of the stock shows signs of Foot & Mouth (FMD) or other notifiable disease.
4. **CLEANSE & DISINFECT (C&D)**
All vendors bringing stock must comply with the Cleansing and Disinfection Order 2003 – i.e. they must CLEANSE AND DISINFECT their vehicle either by using the facilities provided at the Venue or by thoroughly cleansing the vehicles upon reaching home – within 24 hours.
5. **PROTECTIVE CLOTHING/BOOTS**
No Vendors, their staff or agents will be allowed within the livestock holding pens unless wearing the correct clean protective clothing which includes Wellington Boots and/or rubber soled work boots, smock/overalls or waterproof coats and leggings that can be cleansed and sprayed down.
6. **ALL BIO SECURITY MEASURES MUST BE STRICTLY ADHERED TO.**
7. All animals are sold under the Rules and Regulations of the Dorset Down Sheep Breeders' Association Conditions of Sale

No registered Ram Lamb or Shearling Ram shall be sold by Auction at less than the upset price of £250. Purchasers are requested to settle their Account by cash or cheque at the close of sale.
